The fund aims to avoid sharp rises and falls by gradually averaging the price applied to the investment over the first 26 weeks followed by 'averaging' the investment price over a rolling 26 week period from week 27 onwards

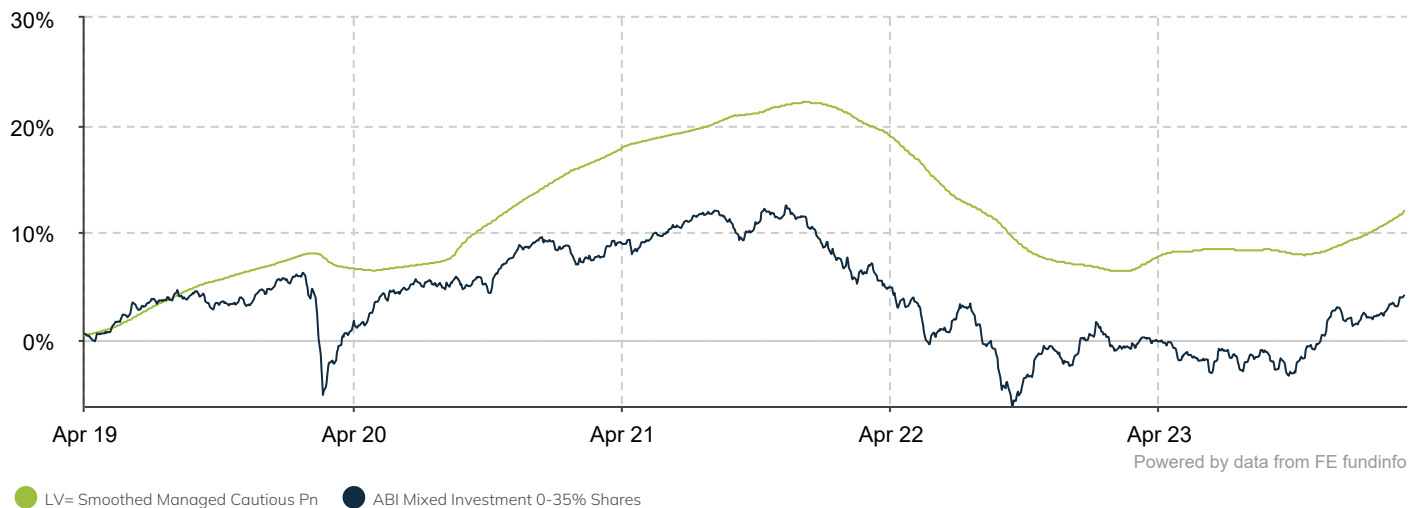
