Fund objective

This fund is designed to provide long term steady and sustainable growth together with a medium level of investment risk. Within this objective we aim to invest in more sustainable assets in this fund. The fund invests, either directly or indirectly, in a diversified portfolio of fixed interest securities, equities, property, cash and other related instruments. The fund aims to avoid sharp rises and falls by gradually averaging the price applied to the investment over the first 26 weeks followed by 'averaging' the investment price over a rolling 26 week period from week 27 onwards.
